Temporary Suspension of Academic Policy Provisions Related to Academic Continuity Response to COVID-19

- This policy is intended to allow broadened flexibility to faculty to as they endeavor to continue to deliver instruction during the campus response to COVID-19.
- For the remainder of the 2020 Spring Semester, all university, college, and departmental
 policies provisions affecting the following will be suspended:
- requirements that faculty meet with their classes at officially scheduled times and places,
 following the modality published in the schedule of classes
- requirements that would prevent faculty from deviating from the published syllabus
 regarding (but not limited to) changes to course modalities; additions of, cancellations of,
 or modifications to assignments (including field trips, internships, and service learning);
 alterations to the scheduling of topics, assignments, or exams; and changes to the
 grading structure of a course
- requirements that would prevent an instructor from altering the time and method ofholding office hours
- 16 4. requirements for submitting textbooks and supplemental materials
- restrictions on what types of assignments are allowed during the last two weeks of
 instruction (i.e. moving assignments to Finals Week and/or offering a Final Exam earlier
 than Finals Week)
- requirements of obtaining prior approval before making changes to a course that would
 cause more than 50% of the instruction time to be conveyed in a digital environment
