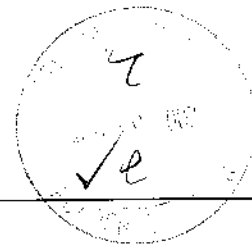

JUSTIFICATION:

Currently, TESOL students who choose the thesis or project options register for ENGL 500. However, this course is supervised by the Coordinator of the MA English program rather than the TESOL Program Coordinator, which causes administrative issues and has delayed graduation. Requiring all TESOL students to register for a single TESOL culminating experience should alleviate this situation.


