CE 137 introduces the topics that are covered in greater depth in this technical elective course. To accommodate students taking CE 137 concurrently (the old prerequisite), a significant fraction of time in this class had to be given to CE 137 topics. By requiring students to finish CE 137 before taking this course, this duplication of coverage is eliminated and more time will be available for advanced topics in this course.



