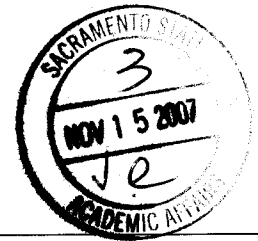

JUSTIFICATION:

I currently introduce students to Hindu religious traditions—the study of which is my own specialty within religious studies—in several existing courses, including the broad survey “Arts & Ideas of Asia” and the more regionally specific “Religions of India.” Yet due to time constraints and the vastness of the topic, I cannot fully represent the full diversity of Hindu ideas and practices as they have developed over at least three and a half millennia in and around the Indian subcontinent. As a result, students in my classes often express interest in finding out more about Hindu traditions, especially since the tradition has in the last century & a half made a significant global impact, as evidenced by the fact that Hindu ideas and communities—many of which meet in newly constructed temples—have spread to Europe, North America, Africa, East Asia, Southeast Asia and Australia. Comparable universities already offer a survey of Hindu traditions; thus I am proposing a set of two courses to include fuller representation of these important traditions in our department curriculum.
