JUSTIFICATION:

The Deaf Studies program may in the future propose a new course focusing specifically on aspects and issues of education pertaining to Deaf and Hard of Hearing people. This change is primarily to eliminate potential confusion regarding the content of the two courses by removing education from the title of this course. In addition, there were a number of erroneous additions to the course catalog regarding prerequisites for this course; this change aims to correct these errors.




