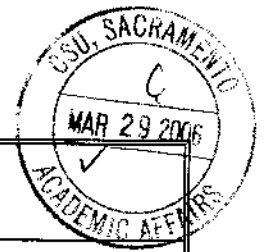

<b>Briefly describe the program proposal (new or change) and provide a justification.</b> The existing Preliminary Administrative Services Credential is being modified in order to meet the new California Commission on Teaching Credentialing accreditation requirements. All electives were eliminated from the new proposed program. The new program kept several of the existing courses (EDLP 202, 203, 255 and 495). We added EDLP 250 as a requirement to the new proposed program. Several courses were modified and new ones created 200 (200B), 201 (201B), 204 (204B), 205, (205B) and 209 (209B). The total number of units remained at 33. The revised course descriptions are included in FORMS A.
