VI. AMERICAN INSTITUTIONS (0-6 UNITS)

If the American Institutions requirement is satisfied by examination, units must be taken in Category IV to total 12 units in THE INDIVIDUAL AND SOCIETY.

ADVANCED STUDY:

Students must take 9 units of upper division, of which three units must be Advanced Study in the G.E. program.

- (2) Development committees should be established with representation from appropriate departments to offer help in designing and developing courses in such areas as Oral Communication, Critical Thinking, Advanced Study and World Civilizations.
- (3) If the General Education Program includes floating units, a course may apply to only two requirements in the General Education Program.

¹Majors in Accountancy will be required to take no more than 60 units in meeting the combined CSU and the present AICPA general education requirements.

The following two resolutions were adopted by the Senate Executive Committee on May 3, 1982. Their aim is to set future directions for the implementation of the General Education program. Like the new program itself, they come to the Senate as seconded motions from the Executive Committee.

- Whereas, The General Education Program is to be administered in the School of Arts and Sciences; and
- Whereas, There is a need to integrate the course approval process for the General Education Program with the functioning of the A&S Curriculum Committee; be it
- Resolved, That the Academic Senate, in Fall, 1982, shall review and recommend appropriate changes in the composition, charge and reporting relationship of the General Education Committee.

Whereas, The Academic Senate, on behalf of the faculty, is responsible for the development of the General Education Program; and

Whereas, The newly adopted General Education Program is incomplete in that it includes categories that were not defined in the 1980-82 Senate approved program; and

Whereas, The General Education Committee shall recommend to the Senate, through the Executive Committee, on any proposed change in a feature of the program which has been established by the University; be it

Resolved, That the Academic Senate shall refer the program to the General Education Committee for the Committee's recommendation of criteria for each of the categories; and be it further

Resolved, That the Academic Senate shall consider their recommendations in establishing criteria for each of the categories in a complete, Senate approved program.
