That individual faculty members and departments be encouraged to further in Resolved:

their classrooms and among their students an on-going dialogue that will support both an appreciation of diversity and a recognition of commonality by incorporating, wherever pedagogically appropriate, relevant issues into course

FS 00-85/Flr. RESOLUTION OF COMMENDATION--JAN MCPHERSON

- Whereas, After twenty-two years as a member of the staff of California State University, Sacramento, and nineteen years as the mainstay of the Academic and Faculty Senates of CSUS, Jan McPherson is preparing to retire; and
- Whereas, During her years with the Senate, Jan McPherson has patiently endured the reigns of Chairs Jerry Tobey, Alan Wade, Peter Shattuck, Juanita Barrena, Charlotte Cook, Sylvia Navari, Mike Fitzgerald, Tom Krabacher, and Bob Buckley, each of whose eccentricities she has tolerated with the utmost cheerfulness and professionalism; and
- Whereas, During her years with the Senate, Jan McPherson has bravely survived interactions with a thousand faculty members serving as Senators; has efficiently supported Senate committees and task forces, as well as nine hundred University committees; and has stayed seemingly awake through three hundred Senate meetings and four hundred and eighty Executive Committee meetings, all of which required agendas and minutes; and
- Whereas, Nevertheless, Jan McPherson has never been heard in public to utter any epithet more intense than an inhaled "Oh" followed by a slowly exhaled "K" Ohhh-Kayyy"; and
- Whereas, Jan McPherson has held the titles of Administrative Aide, Administrative Assistant, Administration Operations Analyst (both I and II), and Administrative analyst/Specialist-Non-Exempt (AAS-NE), without ever changing what she actually did; and
- Whereas, The Faculty Senate feels deeply aggrieved at the prospect of losing Jan McPherson's support, it recognizes that she deserves a retirement devoted to gardening, traveling, reading, crocheting, knitting, walking, wine-tasting, falling off bicycles, singing, caring for cats (including Cuddles) and turtles (including Ivan the Terrible), taking piano lessons, and serving as an officer of the Order of the Eastern Star; therefore, be it
- Resolved: That the California State University, Sacramento Faculty Senate, for itself and on behalf of previous Faculty and Academic Senates, expresses its immense gratitude for Jan McPherson's competence and efficiency, its intense admiration for her patience and good humor, and its sincere best wishes for a long and happy retirement.
