# FS 16/17-124/FLEndorsement of the Immigration and Customs Enforcement on Campus (Interim)<br/>Policy (ADM-0183)

The Faculty Senate endorses the administrative policy entitled Immigration and Customs Enforcement on Campus (Interim).

The Faculty Senate also applauds the open call for feedback and input with regards to development of policy to succeed this interim solution, and endorsement of the interim policy should not be seen to detract from or deter from that process.

## COMMITTEE OF THE WHOLE DISCUSSION

The body discussed how the Faculty Senate would provide feedback to the President on the Immigration and Customs Enforcement on Campus (Interim) Policy (<u>ADM-0183</u>). There was widespread agreement that the policy should be referred to the Committee on Diversity and Equity (CODE) and the Faculty Policies Committee (FPC); an online opportunity for anonymous feedback and comment was also suggested. Several questions were raised that CODE and FPC could also address:

- How does this policy affect faculty who may have been impacted by the travel bans?
- What are faculty responsibilities to students in this context?
- What resources exist to help the campus community, including faculty?
- What opportunities may be avoided because of this?
- What do we do when people leave the campus for conferences or travel out of country?
- Feedback from CODE and FPC should be brought back to the Senate.
