As you know, effective January 1, 2009, the CSU selected five fund sponsors for your TSA investment options. The open enrollment period is November 3 - 28, 2008. All current participants in the CSU TSA program who wish to continue must enroll via the online enrollment process. For further information regarding the newly restructured TSA program, go to www.calstate.edu/hr/benefitsportal.

The Office of Human Resources - Benefits is pleased to announce that we have scheduled on-campus TSA vendor information sessions. Each fund sponsor will provide a 30-minute Powerpoint presentation as well as assistance with the online enrollment process (see schedule below). The approximate length of each session is one hour. Attendance at the vendor sessions is considered release time. Sessions offered during work hours require the approval of your supervisor. Except where indicated below, both the presentation and vendor assistance with the online enrollment will be held in the same locations. All representatives will be available all day (9:00 - 4:00) for walk-in consultations and specific questions.

We encourage individuals to please register for the vendor information sessions to ensure appropriate room capacity. However, individuals who are unable to register are welcome to attend. To register, go to www.csus.edu/hr/TSAsessions.htm.

In addition, the Benefits Office will be available from 10:00 - 3:00 in the University Union Oak Room on November 3rd, 4th, & 17th for those who do not wish to attend a vendor session but need assistance with the online enrollment process. We will have several laptops available during this time. Effective November 3, 2008, you may also enroll from your personal computer by accessing www.calstate.edu/hr/benefitsportal and click "Retirement Manager" under the Tax Shelter Annuity heading.
