- TYPE OF CONTEST:** Individual/Team
- COMPOSITION OF TEAMS:** 1 -2 students per team
- NUMBER OF TEAMS:** 3 teams per Center

- OVERVIEW:** Students will design and create a Website. Judges will view and judge the website one week in advance of the MESA Day Competition. Students will also give an oral presentation on MESA Day.
- MATERIALS:** The following materials will be provided by the Host Center:
- Internet ready computer at the competition
 - LCD Projector to display the website
 - CD-R for storing web pages
- RULES:** Any violation of these rules will result in disqualification.
1. In advance of the competition date, students will design and create a Website.
 2. Website topics will be provided by the workbook sponsor by August 1st.
 3. Students must be the sole designer of their website.
 4. Proper labeling:

- The CD-R itself must be properly labeled with the students' names, grade levels, school and MESA Center. Failure to do so will result in a 10 point deduction.
 - The first page (homepage) of the website must include a "Contact Us" link to a "Contact Us" informational web page which displays the students' names, grade levels, school and MESA Center.
5. The Website must have a minimum of 4 web pages linked together, including the "Contact Us" informational web page mentioned in rule #4 above.
 6. Maximum limit for the entire Website is 5 web pages and 5 MB.
 7. Any photographs, text, trademarks, or names that are used on the site must be supported by proper documentation and approvals. The documentation/approval must be posted directly below the paragraph, text, trademark or name. Students are expected to follow all applicable copyright laws and may be disqualified if items are used inappropriately and not documented.
 8. One week prior to MESA Day, students will submit a CD-R, clearly labeled with the team members' names, the school and the MESA Center, to the contest destination.
 9. One week prior to MESA Day, judges will judge the websites using the Website Design Prejudged Score Sheet (attached).
 10. No changes can be made to the websites after the official submission date.
 11. On the day of the competition, students will present their websites to contest judges. The oral presentation will be judged using the Website Design Oral Presentation Score Sheet (attached).
 12. Students will draw numbers to determine their speaking order.
 13. The oral presentation is an explanation of the website. The website should be shown when explaining the site. The explanation should include, but not limited to:
 - Development of the topic
 - Development and design process
 - Use and implementation of media elements
 - Copyright issues with pictures, music, etc.
 14. Students failing to report on time for the oral presentation will result in 0 points awarded for the Oral Presentation.
 15. Three (3) minutes will be allowed for the Oral Presentation.
 16. Judges will provide time signals for students at these intervals: 1 minute, 30 seconds, and 5 seconds before time is called.
 17. When the presentation is finished, the judge will record the time used, noting a deduction of 15 points for any presentation over 3 minutes.

18. Following each presentation, the judges may conduct a 2-minute question-and-answer period during which students should be prepared to defend all aspects of their website presentation.
19. The performance is closed to observers. Only judges will be allowed in the room.

RECOMMENDATIONS AND GUIDELINES:

1. Specific Website elements may include any of the following:
 - A. Heading tags
 - B. Specific text formatting (bold text, centered, italicized, etc.)
 - C. Use of background color or background images
 - D. Audio clip inserts
 - E. Video clip inserts
 - F. Order lists, unordered lists and definition lists
 - G. Image/graphic inserts with specific attributes
 - H. Relative links
 - I. Target links
 - J. Absolute links
 - K. Email link
 - L. Tables
 - M. Use of Cascading Style Sheets

JUDGING:

1. Competitors will be judged on the following categories:
 - A. Prejudged Website (Maximum score is 100 points)
 - i. Page layout and design
 - ii. Content
 - iii. Technical aspects
 - iv. Specific website elements
2. Oral Presentation (Maximum score is 100 points)
 - i. Explanation of the Website development and design process.
 - ii. Delivery of the presentation
3. Judges will rank students' place based on the total points. The team with the highest score places first.
4. In the event of a tie, the website with the smaller total file size will be declared the winner.

AWARDS: Awards are given for 1st, 2nd, and 3rd place.
