



Summer 2024 classes are offered at Sacramento State through the College of Continuing Education (CCE). Eligibility, class sessions, registration, and fees are set by the CCE. Visit the CCE's website for details (www.cce.csus.edu/summer).

Who's Eligible

Continuing students who completed the formal admissions process and were enrolled in Spring 2024 or Fall 2023, but will not graduate prior to Summer 2024. *Enroll starting April 8.*

Community members who are not formally admitted to the university or students who have been admitted to another college **and** students who have been admitted to Sacramento State for Fall 2024. *Enroll starting May 1.*

Sessions Offered

First 6-week session (6W1) from May 28 – July 7; **Second 6-week session (6W2)** from July 8 – August 18; **Full 12-week session (12W)** from May 28 – August 18.

Registration Cost & Fees

- **Undergraduate Courses:** \$302 per unit; plus \$535 Campus Mandatory Fees (CMF)*
- **Post Baccalaureate Courses:** \$350 per unit, plus \$535 Campus Mandatory Fees (CMF)*

How total costs are calculated below:

EX: Undergraduate enrolls in 6 units → (6 units x \$302 per unit) + \$535 CMF = **\$2,347**

EX: Graduate student enrolls in 3 units → (3 units x \$350 per unit) + \$535 CMF = **\$1,585**

***Campus mandatory fees are required by all students enrolled in the summer session and cannot be waived. Fees include: Health Services \$146, Health Facilities \$28, Associated Students, Inc. \$35, University Union/WELL \$318, and Instructional Related Activities \$8) which total to \$535.**

The campus mandatory fees are charged at a flat rate of \$535 regardless of the number of units enrolled. Please note that fees will be charged to your account in TWO parts. The course fee charges will appear on your account the day after you register. The campus mandatory fees (\$535) will be calculated later (may take up to a week to appear on your student account).

Financial Aid

The Summer Pell Grant and Federal Student Loans are offered to qualified continuing Sac State students only. New students starting in the Fall 2024 are not eligible.

Eligible students must meet the all the standard criteria below to qualify:

- ✓ Must have a 2023-2024 FAFSA filed by June 30, 2024.
- ✓ Must meet Satisfactory Academic Progress by the end of Spring 2024.
- ✓ Must enroll in at least half-time (6 units undergrad/ 4 units post-bac).
- ✓ Must have Pell Grant and/ or Federal Loan eligibility.

Summer Pell Grant is offered to undergraduates and eligibility is based on remaining life-time limits. Aid consideration begins upon enrollment into one class and should reflect on your *Student Center > View Financial Aid link* if awarded. Amounts will vary based on your own individual file and eligibility. Refer to your recent fall/spring semester financial aid award letter to determine how much you may qualify for the summer.

EX: If you received a Spring 2024 Pell Grant at \$3,447 at 12+ units (full-time) you may be eligible for a the Summer Pell Grant for the same amount at full-time or half the amount at \$1,724 at 6 units (half-time). Note: Award amounts will vary based on the student's eligibility and enrolled units.

Summer Loan is offered to undergraduates **and** post-baccalaureates based on Federal Subsidized/ Unsubsidized loan eligibility. Students who are interested must submit the *Summer Loan Request e-form* located on your *Student Center > Financial Aid Links section*.

EX: If you have any federal student loans (subsidized or unsubsidized) that was not used from the current fall/spring semester, you can apply that towards a summer loan. Note: Award amounts can vary based on enrolled units. *You must be enrolled in at least half-time to qualify.*

Summer Provost Grant (SPG) is offered to qualified students who are part of Sac State's graduation initiatives. Award amount will vary based on available funding and eligibility. If awarded, it will be automatically posted on your Student Center > Account Activity page as "Transfer to Sum Provost 3rdPar" with the listed amount on the Payment column. Transactions typically post within 2-3 days of enrollment into one class. NOTE: SPG will be applied to the course fees only.
