



Annual California Campus Safety Plan Report 2018

Availability, Location, and Methods to Summon Law Enforcement Assistance

Enforcement and Arrest Authority

The California State University, Sacramento Police department is located at 6000 J Street, Sacramento, CA, 95819 and provides police services 24 hours a day to our community. Police Dispatch can be reached directly 24 hours a day by phone at 916-278-6000. The peace officers of Sacramento State have state-wide police authority and jurisdiction per Penal Code 830.2 and Education Code 89560, and are vested with law enforcement powers and responsibilities, identical to the local police or sheriff departments in your home community.

Local Police

Crimes occurring off-campus should be immediately reported to the appropriate law enforcement agency of jurisdiction:

Crime Reporting

The entire campus community is strongly encouraged to report any and all known or suspected incidents of criminal activity on campus to the Sacramento State Police Department as soon as possible. When calling Sacramento State Police Department always:

- Give your name, telephone, number, and location.
- Give clear and accurate information.
- Be prepared to supply suspect and vehicle description, and direction of travel.

Emergency Blue Light Call Stations

A 24-hour, button activated, emergency telephone system will put you in contact with emergency personnel for any emergency need. There are 200 call stations located through Sacramento State campus, including residential housing.

Special Safeguards for Facilities or Activities

Security of and Access to Campus Facilities

All campus facilities are key-accessed, and most are open daily for scheduled campus community use. Access to Housing and Residential Life complex is with key access only. Campus key control and distribution is a function of Facilities Services. To provide for the security of campus facilities, Sacramento State Police Department enforces Educational Code 89031 & Housing Policies. Campus facility access may be revoked per Penal Code 626.

Special Considerations used in Maintenance of Campus Facilities

Regular inspections and surveys of campus indoor/outdoor lighting, shrubbery and walkways are conducted. The University participates in Crime Prevention through Environmental Design concepts for planning and improvements on campus. Lighting surveys are conducted twice annually so that improvements or repairs can be made to various locations on campus. All emergency “blue-light” telephones are checked by the Sacramento State Police and repairs are conducted.

New Student and Employee Orientations

Sacramento State Police Officers provide personal safety tips and emergency contact information to new students and employees on a regular basis. They are informed of policies, voluntary confidential crime reporting procedures, and safety programs.

Emergency Training and Exercises

The Sacramento State Police Department provides Emergency Response training courses throughout each academic year, including Building Team Emergency Preparedness, Campus Emergency Disaster Preparedness, Campus Clergy Training, Active Shooter Training, Violence in the Workplace Prevention, and Self-Defense and Personal Safety Training. The Police Department hosts a regional table-top exercise each year to test the response of campus departments and allied agencies on a variety of scenarios, including Hazardous Materials Spill, Flood, Fire, Active Shooter, and Pandemic Virus. Furthermore, Building Evacuation Drills are required annually for each campus building.

Actions in the Last 18 Months to Increase Safety

1. Increased number of CSO's to enhance campus security; increased patrol in parking lots identified as problem areas to mitigate crimes.
2. Provide extended safety escorts for Residential life parking in Parking Structure.
3. Launched initiative to install new mechanical locking mechanisms in select classrooms for classroom doors.
4. Installed new surveillance cameras, interior and exterior; repaired, maintained and upgraded existing cameras around the campus and Residence Halls.
5. Upgrades in process for Campus Data Center Head End CCTV system.
6. Repaired and replaced numerous Emergency Blue-Light Phones on campus; added additional Blue Lights around campus.
7. Tested, fixed and replaced DMP Alarm system components, achieved full campus system testing, implemented repairs.
8. Provided Active Shooter training, Building Coordinator/Floor Marshal training, Campus Disaster/Emergency Preparedness training, Self-Defense training and Violence in the Workplace training.
9. Assessed the campus safety environment to remove hedges and bushes to mitigate crimes and increase safety.
10. Added pedestrian sidewalk from Lot 11 as a result of City's remodeling of intersection at North end of campus.

Changes in Safety Precautions During the Next 24 Months

1. New access features for classrooms to replace existing key locks. This will allow for quicker lock down.
2. Evaluate requests for new surveillance cameras on campus.
3. Large scale exercise will be conducted as part of the emergency preparedness program.
4. Adding enhanced lighting to campus walkways and building exterior pathways.

5. Re-engineer left turn lane on State University Drive and Lot 7 to enhance vehicle flow and reduce collisions.
6. Parking structure will be restripe to increase size of compact lot to minimize accidental vehicles door damage.
7. Active shooter training will be available online through SkillPort so that all users are able to take the training.
8. Ground signage will be added to provide notice that wheeled vehicles are prohibited on pedestrian walkways throughout campus.
