Fall 2014 Financial Deadlines

Provided by the Financial Aid Office and Student Financial Services Center

August 2014

August 18th-28th: Late Registration

Student has 7 calendar days to pay fees and \$25 late registration fee is added to student's account

August 28th: Re-enrollment Fee

Starting today students who are canceled for non-payment will incur a \$100 fee to re-enroll.

August 29th: 100% Refund Deadline

Student may receive a 100% refund (minus a \$10 processing fee) if classes are dropped before this date. See withdrawal information below.

September 2014

September 2nd: Late Registration

Student has 2 calendar days to pay fees and \$25 late registration fee is added to student's account. If students withdraw after instruction begins they will be charged a pro-rated fee based on the number of days they remained enrolled.

September 12th: Drop-in Units Refund Deadline

Students who drop from full-time to part time need to do so by September 12th in order to receive a refund of the price difference. (Part time is 6 or fewer units.)

September 17th: Financial Aid Deferment Removed

Financial Aid removes their fee deferment and students are required to pay any balances due. All those who do not make sufficient payment may be dropped from their classes.

September 17th: Installment Payment Plan **Deadline and 2nd Payment Due**

Last day for students to sign up for the Installment Payment Plan (IPP) through their MySacState account. Down payment and 2nd Payments are due. Students should check their Student Center for current amount owed.

September 29th: Census Date

Deadline to add or drop classes. If a student wishes to sign up for classes, they must appeal through the Registrar's Office and pre-pay the total amount due with guaranteed funds before they are added. No Financial Aid adjustments will be made to awards after this date. Last day to submit a Financial Aid SAP appeal.

October 2014

October 17th: 3rd Installment Payment Due

Students should check their Student Center for current amount owed.

November 2014

November 6th: 60% Refund Deadline

Deadline to withdraw from the university and be eligible for a pro-rated refund.

November 17th: 4th Installment Payment Due

Students should check their Student Center for current amount owed.

Withdrawing from the University:

Students withdrawing from the university need to complete ALL of the following steps:

- 1) Drop all of their classes.
- 2) Complete a withdrawal form found at www.csus.edu/registrar/forms
- 3) Submit completed form to the Student Services Counter in Lassen Hall by September 12th.
- 4) If withdrawing after September 12th visit the Academic Advising & Career Center, Lassen Hall 1013.
