Justification for course proposal:

The requested changes are to inform students of the fieldwork requirements and add learning objectives that are not reflected in the workflow but previously approved via a Form A in 2007. First, the added course note aims to inform students of the number of hours of fieldwork and clearance procedures that are necessary to complete the course. These changes aim to mitigate miscommunication with students regarding the scope of fieldwork and associated requirements. Second, course learning objectives were added to this form solely to reflect the previous learning objectives that were not in the curriculum workflow given they were created before the transition to a digital system. The learning objectives were adapted from a Form A approved in 2007 and modified to use better reflect bloom's taxonomy; no substantive changes were made to these learning objectives.
