As we have increased the number and scope of required courses for the English MA, we believe the new coursework requirements will more effectively prepare students for their culminating experience. Believing that coursework will now prepare students more effectively for their thesis or comprehensive exam, we are reducing the number of units dedicated to the culminating experience.

We are also including in ENGL 500 an assignment which asks students to reflect on and edit their portfolio projects from their MA coursework, required to be saved to a learning management system, that address research, scholarly dissemination, pedagogy, and professionalization.
