#### Justification for course proposal:

Currently students in the Hospitality and Tourism Management (HTM) emphasis area of the Recreation and Park Management (RPM) program take RPTA 62: Introduction to Recreation Law as their law course requirement in the program. RPTA 62 is very appropriate for public recreation students, but as HTM becomes separate from RPM, students need a more specific course as part of their curriculum that focuses on for-profit, experiential products. This course was developed as a part of RPTA's redevelopment of course offerings in hospitality and tourism management. This is being done for several reasons:

- -Student interest in hospitality and tourism
- -The Chancellor's Office push to develop/expand hospitality program offerings at the CSU campus
- -Visit Sacramento's and the Sacramento Hotel Association's desires to work with RPTA to expand/elevate the hospitality and tourism program at Sac State
- -The recently approved Transfer Model Curriculum (TMC) in Hospitality Management between the CSU and the California Community Colleges (CCC)
- -The recent hiring of two tenure track faculty in the area of hospitality management (and the current search for a third faculty in the area of tourism).

The course, RPTA 82: Introduction to Hospitality and Tourism Law, is a standard course in hospitality programs, and this will help to bring the Sac State program more in line with similar hospitality and tourism programs at CSU, East Bay and CSU, Chico, and other programs throughout the state and country. As mentioned, the course will replace RPTA 62: Introduction to Recreation Law for students focusing on Hospitality and Tourism Management.

This course provides insight into the laws and regulations governing the hospitality and tourism industries with an emphasis on labor relations and human resources best practices. The course addresses the general concepts of tort, contracts, liability, risk management, employment practices, licensing, and insurance needs. The course also explores the legal issues that today's industry professionals face such as privacy, labor laws, the common law system for innkeepers and newer hospitality products in the shared economy such as AirBnB or VRBO.
