We propose changing the course prerequisite from SPAN 2B (Intermediate Spanish) to SPAN 47 (Introduction to Composition and Grammar Review) and elimination of the note that recommends SPAN 47. It has become apparent that language proficiency acquired through SPAN 2B is not sufficient for students to be successful in SPAN 103. It is also fitting in light of recently approved changes to SPAN 102, SPAN 151, SPAN 152, and SPAN 153, also making SPAN 47 a prerequisite.
