### Briefly describe the program proposal (new or change) and provide a justification:

Allow students with a 3 or higher score on the AP American Government Exam to satisfy requirement for POLS 1, as it shows sufficient competence in this area.

Expand options in upper-division major required courses from POLS 110 or POLS 111 to POLS 110 or POLS 111 or POLS 112 (adding POLS 112 as an option to choose from in that category).

Add Introduction to Comparative Politics (POLS 140) as a requirement for the BA

Increase total units required from 39 to 42

Justification: Expanded options in the requirement in political theory (Political Thought courses POLS 110, 111 or 112) will allow students more flexibility in pursuing their interests and completing requirements in a timely fashion.

Comparative Politics is a primary subfield in the discipline of Political Science and a requiremnt in almost all undergraduate political science programs, as well as the major exposure undergraduates receive to the domestic political institutions and cultures of non-U.S. societies.

The expansion of unit requirement is to require the same number of electives for depth of the major; as one of the lowest unit majors on campus, Political Science will still be below average and will be able to continue the steady progression of students without delays, while recent hires were specifically made to expand our ability to offer POLS 140 in multiple sections on a regular basis.

### Objectives of the degree program:

Provide a comprehensive education in the broad fields of Political Science and develop skills and knowledge that allow students to analyze and address politics and dynamics of governance.

# **Program Description**

The Political Science major complements a student's liberal arts education with an emphasis on understanding the theoretical and practical aspects of government and politics. The department offers a BA in Political Science, a BA in Political Science-Journalism, and the minor in Political Science. The Political Science major is structured to provide students with a comprehensive background in the basic fields of political science, as well as to permit them a range of choice in completing the program. The Political Science Department offers several courses integral to interdisciplinary programs such as California Studies, Environmental Studies, Ethnic Studies, Peace and Conflict Resolution Studies, and Women's Studies.

The department emphasizes its expectation that students seek faculty advice when planning their program. Students may ask any faculty member's assistance initially. As specific interests are developed, students may wish to seek the advice of faculty sharing their interests.

**Note:**Although it is not a requirement of the major, the department**strongly recommends**that students take an introductory statistics course as part of their undergraduate work. A course in statistics may be used to satisfy the GE requirement in mathematics.

Kathy Garcia (kathy.garcia) (Mon, 22 Apr 2019 20:25:58 GMT): Rollback: Comments from the Faculty Senate Executive Committee: 1) The proposal lists POLS 112 as a new option in the Political Theory requirement. However, there is no "Political Theory" requirement listed in the proposal. In fact, there is no Political Theory requirement listed in the current catalog, so technically, it doesn't exist in terms of what students need to adhere to. The only requirements for a BA in POLS are the lower and upper division core courses and 21 units of electives. If the Department wishes to have additional requirements (e.g. a Political Theory requirement) they need to be listed in the catalog. 2) The current catalog shows that for the upper division core requirements either POLS 110 or 111 need to be taken, and either POL 120A or 120B need to be taken. The new proposal has omitted POLS 111 and POLS 120B as options for students to take but there is no justification for why they are being dropped. If this was an unintentional omission, then the courses should be simply added back to the proposal. If the omission was intentional, then a brief rationale should be included. 3) In the Notes section, it states that only 3 units of POLS 195 can count toward the 33 units of upper division coursework. However, with the additional of POLS 140, there are now 36 units of upper division coursework. My suggestion for a fix would be to simply have the sentence read: "Students may take a maximum of 6 units of a POLS 195 (Internship), but no more than 3 of those units may be applied to the major." In the version we were given for review (and there may have been updates already made to the online version?), The number of courses and units didn't seem to add up correctly. But there were other comments made to suggest that this might have been something to do with the version or the way the courses were listed, so it remained unclear. With respect to the added elective course, if they don't list electives in the catalog anyway, it doesn't seem like a program change. But if there is, in fact, a restricted list of approved electives (?). It should probably be included (as with Child Development a year or two ago). Otherwise something like "electives chosen in consultation with a major advisor" basically covers all bases and allows the faculty to switch what they're willing to accept from time to time as courses come and go.
