#### Briefly describe the program proposal (new or change) and provide a justification:

We aim to update the program to streamline and reduce course prerequisites, eliminate an obsolete internship requirement, and provide applicants with significant professional experience the option to waive the GRE. Our larger intention is to make the program more attractive to applicants and simpler for current students.

More specifically, we aim to address the following issues with our programmatic changes: 1) concerns raised by recent social science research about the validity of the GRE as an indicator of likely success, combined with concerns about taking a standardized test expressed by potential applicants with significant, highly valued professional experience; 2) past experience indicating that students with GPAs a little below 3.0 and other strong attributes can succeed in our graduate program and their subsequent careers; and 3) indications that virtually all of our students succeed in obtaining an internship or other appropriate professional experience without taking PPA 295, making that course redundant and potentially burdensome. Furthermore, we have identified minor discrepancies between our program as stated in the catalog and evolving practice (e.g., the campus only needs one set of official transcripts), making catalog clean-up desirable.

## **Admission Requirements**

Admission to classified standing in the program requires:

- · the baccalaureate degree;
- a GPA of 2.75 for all undergraduate coursework or in the last 60 units;
- results of the Graduate Record Examination (GRE) General Test; the department chair may waive this requirement for an applicant with at least five years of professional experience in the area of public policy and administration;
- · completion of the following (or their equivalents at other colleges or universities as determined by the Department Chair):

• a written statement of purpose from one to two pages in length (typewritten), addressing the applicant's purpose in pursuing the Master of Public Policy and Administration;

- A minimum score of 83 iBT (560 Paper Based TOEFL) or 6.5 IELTS. All applicants to graduate programs who have not completed
  a baccalaureate degree from a postsecondary educational institution where English is the principal language of instruction must
  achieve a minimum score on TOEFL or IELTS;
- three letters of recommendation from individuals with knowledge of the applicant's academic and professional potential.

A student with certain deficiencies in the above requirements may be admitted to the program on a conditionally classified status. Admission conditions will be determined on an individual basis.

#### Admission Procedures

All prospective students must file the following with the Office of Graduate Studies:

- an online application for admission;
- one set of official transcripts from all colleges and universities attended, other than Sacramento State; and
- · GRE scores.

## Minimum Units and Grade Requirement for the Degree

Minimum Cumulative GPA: 3.0 with no grade lower than a "B-" in all required courses (and "credit" for PPA 500).

### **Advancement to Candidacy**

Students must file an application for Advancement to Candidacy listing their program of graduate study. The filing procedure should begin as soon as the student has:

- · removed any deficiencies in admission requirements;
- completed at least five of the program's required courses with a minimum grade of "B-" in each and a cumulative grade point average of at least 3.0; and
- Satisfy the Graduate Writing Assessment Requirement (GWAR) by completing one of our Departmental Graduate Writing Intensive (GWI) courses with a grade of "B" or better (eitherPPA 200 orPPA 220A) or meeting one of the other standards set by the Office of Graduate Studies.

- At the discretion of the Department Chair, PPA 295may be waived for students with one year of administrative and analytical experience in a full-time professional capacity in the field of Public Policy and Administration.
- PPA graduate students are required to take 6 units of elective courses. Ordinarily at least 3 of these units should be chosen from among the graduate level elective courses offered by the Department of Public Policy and Administration. As appropriate, the requirement to take at least 3 units within PPA may be waived with the approval of the student's academic advisor and the Department Chair.
  - Additionally, the Department has offered experimental PPA 296 electives in the past, and will continue to do so.
- Enrollment inPPA 500is required of students in their last semester of enrollment in the program. Each student will undertake a project or thesis dealing with a policy or administrative issue and complete a significant written work detailing the problem or issue examined, sources of information used in analyzing the issue, and project findings and conclusions.
