This Form B seeks to correct several issues with CourseLeaf converting experimental course numbers RPTA 96A-D to permanent numbers RPTA 60, 61, 62, and 80.

For the 2019-2020 catalog, several RPTA courses were converted from experimental numbers (96A-D) to permanent numbers (60-61, and 80). The conversion was successful for the Bachelor of Science degree, but none of the experimental numbers were changed in the minor. The problem was compounded in that the courses were removed altogether from the minor, leaving students with the impression that the courses no longer counted.

This edit corrects the above issue and also removes a deactivated course (RPTA 160) that was still listed in the minor after deactivation.

RPTA 22 is currently in the approval process.

This is listed as a substantive change because the minor is being reduced from 21 units to 18 units to assist students with a more timely graduation.

The Minor in Recreation Administration is designed for non-RPTA majors interested in learning about career areas within the recreation, parks, and tourism fields. This broad set of industries can lead to careers in community services, natural resource management (as a park ranger), youth leagues and sports, non-profit leadership, adventure recreation, hospitality, campus recreation, activity programming, experiential education, and destination marketing.

Minor students may enroll in department certificates to complete the requirements of the minor. The minor must be completed for the certificate to be awarded.

The minor requires 18 units, all of which must be taken in Recreation, Parks, and Tourism Administration. At least 12 units must be upper division, with at least 9 upper division units taken in residence at Sacramento State.
