## Briefly describe the program proposal (new or change) and provide a justification:

The following changes are being made to the BA in Art History:

1. Revised Program Learning Outcomes: In consultation with Amy Wallace, AVP of Academic Affairs, and Carolyn Gibbs, Chair of the Art Department, we rewrote the PLOs to improve the assessment process. The new PLOs are condensed and more descriptive, while also being more precise about what we expect from our students. These new PLOs were also written in consultation with Studio Art faculty so there is more crossover at the lower division between the various degree programs of the Art Department.
2. Revised Lower-Division Core Requirements: We, Mya Dosch and Rachel Miller, received a College of Arts and Letters Curriculum Redesign Award to revise the lower-division Art History course offerings, to move away from a European-centric curriculum to a more global curriculum. In order to give students both breadth and depth at the lower-division level, students will now be required to select either ART 1A or 1B (both global surveys) and then select two courses from ART 4, ART 5, ART 3A, and ART 3B (more geographically focused surveys that correspond to the upper-division groups). ART 1C will continue to be required of all students because it is the prerequisite for all of the Group 4 upper-division courses. We are adding ART 4 to the curriculum because with the reduced European content in ART 1A and 1B, a focused European survey is necessary to prepare students for courses like ART 106 and ART 107.
3. Revised Upper-Division Core Requirements: We are adding a new course, ART 118C (approved in May 2019), to Group 3. This is a service-learning course taught using local resources, encouraging art history students to gain further experience in the arts of their local community. Because the content of ART 118C overlaps with that of Group 4, we added a footnote clarifying that students can take the course for Group 4 credit instead of Group 3, with approval of an art history advisor. In Group 4, we added a footnote clarifying that we will only accept one history of Photography course for Art History credit (PHOT 101 or PHOT 102) because we want students to be able to study history of photography, but limit these courses to only one in order to have students take more of their core courses in art history.
4. Upper Division Electives: We are removing the three courses (ART 119, 195 or 199) that were listed under "Upper Division Electives," in order to clarify that any upper-division elective course will satisfy this requirement. There has been significant student confusion on this point, as many students thought they could only satisfy upper-division elective requirement with the three courses that were listed here.
5. Changes to Art History Seminar. We have removed ART 196 from the list of possible seminars because it is almost never taught as an art history seminar and this has caused advising confusion in the past.

2. Communicate through artmaking and visual analysis the formal and material qualities and technical processes of creative works
3. Connect art historical concepts to one's own life and contemporary social issues.
4. Articulate a complex understanding of difference by examining artists and artworks from cultural backgrounds different than one's own
5. Identify and apply art historical theories and methods when interpreting works of art and reading primary sources and secondary literature
6. Produce and present a college-level body of research in their chosen area of emphasis

## Program Description

The Art History BA provides a full range of courses in Western and non-Western art, criticism, and visual culture from pre-history to the present and from many perspectives. Lecture/discussion classes, seminars, independent studies, fieldwork, and studio courses produce college-level visual literacy, global perspectives, art historical skills, and understanding of curatorial and art-making practices. Students focus on one of four areas of interest: Early Modern European Art, Asian Art, Art of the Americas, or Modern and Contemporary Art. The art history degree affords a broad education as well as practical preparation for a range of vocations and advanced professional studies. Students who wish to pursue advanced degrees in Art History after finishing the Bachelor of Arts will benefit from the close supervision of a mentor-professor who helps prepare them for graduate studies.
Fieldwork experiences can be arranged with the Crocker Art Museum, Sacramento Metropolitan Arts Commission, and other public and private art institutions and galleries in the Capital region. Opportunities to study art history abroad are available through the Office of International Programs and Global Engagement at Sacramento State and the California State University International Program. University credit can be obtained for a semester to a year of study at college and international centers in Britain, Europe, Latin America, Asia, Africa, and Australia.
California State University, Sacramento is an accredited institutional member of the National Association of Schools of Art and Design (NASAD).

## Minimum Grade Requirement

All lower division art history requirements and demonstrated writing proficiency as prescribed by California State University, Sacramento must be completed prior to enrollment in upper division courses. A minimum grade of " $C$ " is required in all courses applied to the Art History concentration. Art History students are required to meet the Sacramento State Foreign Language Requirement by completing the second semester (1B) of a college-level foreign language course with a grade of C- or better (or equivalent foreign language study, as described in the current University catalog). Students who plan to pursue further graduate study in art history are encouraged to learn a foreign language relevant to their art historical interests through the second semester intermediate level (2B).
