#### Justification for course proposal:

More individuals are killed in genocide and mass atrocity than any other crime in the world. While the world has pledged "never again" mass atrocities continue to unfold across the globe. Atrocity crimes is an emerging CJ field exploring such violence. This course will engage students in the innovative scholarly conversations occurring globally about atrocity crimes and what to do as a society, nation and world in their aftermath. Transitional justice is a range of judicial practices that occur after the most horrific crimes. Because transitional justice occurs after the dissemination of a country or community, traditional mechanisms of justice may not be available or appropriate. In the past three decades transitional justice has emerged as a compelling solution for some of the most dire conditions- with practices ranging from international courts to truth commissions. Students in this course will learn about global cases, courts and organizations- information integral to the study of criminal justice, and globalization more generally. Furthermore, atrocity crimes and transitional justice are excellent case studies to scope test theories on age and crime, gender, perpetration, reconciliation and violence. This course both introduces cutting edge theories and provides case studies in which foundational theories of crime and punishment can be applied.

The main objective of this course is to understand the practice of seeking justice in societies that have experienced mass atrocity. The course is divided into two units: atrocity crimes and transitional justice. In the first unit, students will learn about what constitutes an atrocity crime (war crimes, crimes against humanity, and genocide). In the second unit, students will examine key concepts and explore theoretical and practical problems in confronting large-scale social violence such as war, genocide, and authoritarian rule.

5. Students will apply theories of mass atrocity to a case study of their choosing.
