**Christopher Castañeda (cjc) (Thu, 06 Feb 2020 04:10:01 GMT)**: The A&L Curriculum Committee reviewed FILM 128 at its Feb. 5 meeting, and we are requesting the following changes so that the proposal can move forward: 1) Since FILM 128 is cross-listed with COMS 128, a Form A change proposal for COMS 128 should be submitted at the same time; 2) in the justification section, we recommend adding some additional information re: how these changes will benefit the course/curriculum; 3) in the "Course Description" section, it appears that there should be a colon instead of a semi-colon following "...of production"; 4) although a syllabus isn't required with a course change proposal, we noticed that the course description on the syllabus contains the original course description; and 5) each assessment strategy should indicate which ELO it addresses.
