Justification for course proposal:

We are seeking to re-activate this course; we are not proposing a brand new course. Over the last several years it has been determined that our FACS students are in need of a course in social justice as it relates to family experiences. This course would be cross-listed with other departments, including SOC, ANTH, ETHN, and ENVS. The content of this course will train students to reconceptualize their understanding of 'the family'. Students will gain a new appreciation of how best to serve families and children in diverse settings. Special attention needs to be given and devoted to marginalized families and understudied family topics that are often overshadowed by mainstream family issues. We were not able to identify a course within SSIS that help meets these needs; therefore, we look forward to offering this course to provide students in FACS and across SSIS with the tools to use a critical, social justice lens to study and serve families locally and abroad.

Examines the nature and forms of social justice and injustice. Addresses key philosophical and theoretical models and debates over the meaning of social justice, using historical and contemporary examples to highlight important concepts and controversies. Faculty from different departments will address how their discipline understands and analyzes issues of social justice. Students will be encouraged to critically assess the assumptions of various perspectives on social justice, and to address the relationship of academe and social activism in achieving social justice.
