Based on our last program review, the CHDV major is restructuring. Part of this restructuring includes evaluation of each required course, and modifying the course description and objectives to better align with the Program Learning Outcomes. Therefore, adjustments and improvements have been made to this course in order to align with the program restructuring. First, the course objectives and description have been broadened in order to engage not only students who are interested in working in the teaching profession, but also for those who have goals of working in the community and other non-education settings. We have also modified the objectives to include more socio-cultural content, providing students a more nuanced understanding of language-related processes. Finally, in alignment with the program's name change, we have expanded many of our topics to also include language development through adolescence.
