Based on our last Program Review, the CHDV major is restructuring. Part of this restructure includes evaluation of each required course, and modifying the course description and objectives to better align with our Program Learning Outcomes. CHDV 137 used to have a co-requisite of CHDV 137L - a 1.0 unit lab. We are removing the lab from this course and redistributing the unit to the prerequisite research methods courses (CHDV 123 and CHDV 133). Furthermore, the theory-to-practice component originally in the CHDV 137L course is shifted to a new capstone course (CHDV 190).
