Based on our last program review, the CHDV program is restructuring. Part of this restructuring is the evaluation of each required course, and modifying the course description and objectives to better align with our program learning outcomes. CHDV 138 used to have a corequisite, a CHDV 138L (the lab). We are removing the lab from this course and redistributing the unit to the prerequisite methods courses. Furthermore, the theory-to-practice component originally in the CHDV 138L course is shifted to a new capstone course (CHDV 190).
