Thus, we are deleting CHDV 194: Cooperative Education Experience to comply with updated academic internship practices on campus, and proposing a new course (195) which serves a similar function.

Students receive supervised employment in school districts, state and community agencies, companies and other appropriate settings. Requires regular meetings with faculty supervisor, completion of field study assignment, evaluation by field-based supervisor, and a written final report. The internships can be paid or unpaid.
