### Justification for course proposal:

We are requesting an adjustment to the credit hours to a stable 3 units, taken twice to fulfill a one year long (fall/spring) field study requirement. The students are to acquire 600-800 hours of field experience over the course of an academic year, with an increase for School Counseling to 800 hours of field study/internship due to recent CCTC changes. The CACREP requirement for the other concentrations/specializations includes a minimum of 600 hours of internship/field study. We have traditionally aligned hours in the field with units but that has created problems with students graduating without the minimum 6 units needed. We are changing the fluctuation in units to a steady 3 unit requirement, allowing them to acquire the needed hours of the course of the academic year, ensuring they have the 6 units total.

The School Counseling program is the only program that is both CACREP and CCTC accredited. Due to changes in the CCTC requirement. The increase in field experience is to address the new requirements from CTCC. Based on new Pupil Personnel Services School Counseling Program Standards and Performance Expectations, Commission on Teacher Credentialing (CCTC) is requiring 800 hours of field study instead of 600 hours. Current EDC 480 Field Study in Counseling course allows students to take a maximum of 6 units and these 800 hours of field experience can be conducted during the course of their work within EDC 480. The field work hours increase will not increase the amount of time or money for students as it can be performed within the current 480 structure. Students will continue to take field study in their last two semesters. The increase in field study hours acquisition will allow students to meet the CTCC requirement of 800 hours of field study, and be on-track to graduate within three years.

After successful completion of the 100 hour practicum, students complete 600-800 clock hours of supervised counseling internship in roles and settings with clients relevant to their specialty area. Students will be able to:

1. Students will expertly demonstrate advanced specialty specific skills with clients and/or students and complete at least 240 clock hours of direct service, 120 hours each semester, at their site placement.

2. Students will expertly demonstrate advanced specialty specific skills with clients and/or students and complete at least 360 clock hours of indirect service, 180 hours each semester, at their site placement.

3. Students will actively apply expertise of intervention and case conceptualization through discussions of their cases/case loads during supervision and consultation received through weekly interaction with supervisors that averages one hour per week of individual and/or triadic supervision throughout the internship, provided by (1) the site supervisor and/or (2) counselor education program faculty.

4. Students will apply advanced knowledge of the counseling field, intervention, and case conceptualization, through discussions of their cases/case loads during supervision and consultation provided by their University Supervisor and participate in an average of 1½ hours per week of group supervision on a regular schedule throughout the internship. Group supervision must be provided by a counselor education program faculty member.
