We are changing the ENGL 220C requirement to ENGL 220C OR 220R or 220P to allow students some flexibility in the focus of their studies; we believe the flexibility will also allow for easier completion without markedly changing PLOs and SLOs for the overall certificate since each course focus on graduate level research.
