#### Abstract of the proposal:

1. Propose a Minor in NUFD because the existing Minor in FACS is no longer relevant to the recently elevated NUFD program. 2. Update the core requirement and the list of electives among NUFD courses by replacing FASH courses (Fashion Merchandising and Management) and FSHD courses (Family Studies and Human Development).

3. Reduce the total units required from 24 (3 core units and 21 elective units) to 21 units (15 core units and 6 elective units).

#### Briefly describe the program proposal (new or change) and provide a justification:

In September 2017, we were informed that our current degree program (B.S. in Family and Consumer Sciences (FACS), Nutrition and Food (NUFD) concentration) was non-compliant with EO 1071. In order to comply with EO 1071, our previously existing NUFD concentration was proposed as a stand-alone degree program, "B.S. in Nutrition and Food." This was approved and became effective in fall 2019. As a result of this change, we propose to develop a Minor in NUFD as the existing Minor in FACS is no longer relevant to the new NUFD program. The existing minor is in FACS and contains courses from three disciplines within FACS (FASH, FSHD & NUFD). The proposed NUFD minor is updated to contain the new course codes (NUFD) and nutrition and food focused core and elective courses. This revision can complement many campus-wide majors such as Family Studies & Human Development, Health Science, Public Health, Kinesiology, Nursing, Child Development, Recreation, Parks & Tourism Administration, Psychology, and Gerontology.

The FACS minor currently does not have any students (n=0) enrolled since we have not taken new minors except for a few students who changed from a FACS major to another major. The FACS Department plans to revise the curriculum in the FACS minor due to the recent degree elevations and will determine if a FACS minor is still relevant, needs revision or if individual program minors will replace it, which most likely will be the case. The current FACS minor although not active, includes only 1 required nutrition course (NUFD 10) and the language is outdated referring to FACS concentrations which don't exist. Students interested in a nutrition would be directed to the proposed NUFD minor instead of the FACS minor so there would be no program duplication.
