This proposed course is designed to allow CSAD students to have the opportunity to acquire pre-professional skills in communication needed for the fields of speech-language pathology and audiology while learning about issues relating to diversity and multiculturalism. There are few practical experiences available for undergraduate students in our major. This course will provide students with the opportunity to apply information learned through CSAD 112: Language Science and Development, CSAD 126: Speech Sound Development and Disorders in Children, and CSAD 143: Communication Disorders in Multicultural Populations, while they gain practical experience when interacting with each other, and with individuals outside of the major. This course also acts as a vehicle for student discussions of racism, ableism, cultural competence, and intercultural sensitivity.

This peer-led course is designed to partner students enrolled within and outside of the department of Communication Sciences and Disorders (CSAD) for a mutual exchange opportunity.
