When the program changed from having areas of study (concentrations) to just one general degree, we changed the use of units in this class to just one policy. The program reflects the accurate information about how many units may be applied to the major elective units. This is updating so the course is in alignment with the program requirements.

We reduced the number of times a student could take 199 to 6 times (down from 99) because they could take it 1 unit for 6 different semesters, engaging in multiple projects over time. 3 of the units could be used toward the major, but up to 6 could be applied to 120 total units.
