## Justification for course proposal:

We will add "Third-year Japanese 2" to the current title and delete "the Japanese in America" to clarify the language level and to make it contiguous with the first-year and second-year course sequences. In Fall 2020, the title of JAPN116A, the precursor to 116B, was changed to Third-year Japanese 1.

We are proposing to change JAPN116B from 3 units to 4 units to align with the revised version of JAPN 116A (approved in Fall 2020). Adding a fourth unit will enable us to complete more of the third-year textbook, a standard textbook widely used in the United States and abroad. The course will complete five full chapters per semester instead of the current four. The fourth hour will be used for additional practice and reinforcement. As stated in the JAPN 116A proposal, it takes time for students to master Japanese, one of five languages considered the most difficult for native English speakers to learn (with Korean, Mandarin, Cantonese, and Arabic). Diplomats learning these languages undergo 88 weeks of full time language training, almost four times longer than training provided for French or Spanish. This course is a continuation of JAPN116A. JAPN116B is the second in a two-semester series in advanced (third-year) Japanese. It is designed to expose students to the practical use of advanced structures and to further develop the four language skills listening, speaking, reading and writing. Students will also acquire cultural knowledge necessary for appropriate communication at the advanced level. Taught in Japanese. This course counts towards the Japanese Minor.
