This program has been elevated to a stand-alone degree, BS in Family Studies and Human Development in compliance with EO 1071. The remaining concentration in Family and Consumer Sciences is out of compliance with EO 1071, and per that order, should be discontinued.

This has no fiscal or programmatic impacted on other academic units because the curriculum remains intact in the new degree, BS in Family Studies and Human Development.

Consultation occurred with affected units in the Form B process of elevating the curriculum to a stand-alone degree, BS in Family Studies and Human Development.

Currently enrolled students have the option between the two majors: BS in Family Studies and Human Development, or BS in Family and Consumer Sciences concentration in Family Studies. There were no curricular changes in major requirements, so these options are in title only.

All resources available to support the Family and Consumer Sciences concentration in Family Studies have been shifted to the BS in Family Studies and Human Development
