Justification for course proposal:

We are proposing to modify PSYC 143: Practicum in Community Psychology by (1) transitioning to a service learning course, (2) reducing the number of service learning hours required from 90 to 60, (3) removing a prerequisite and a corequisite, and adding the Peace Corps Prep certificate as an option for a prerequisite, and (4) clarifying aspects of the course in the Catalog Description, Course Note, and Prerequisites. Ultimately, these changes are intended to clarify the nature of the course for students, and to increase the number of students who are able to enroll in the course and engage in this applied experience.

(1) PSYC 143 has been offered since Fall 2017, and the course is currently classified as an Academic Internship course. Given our use of structured reflection since Fall 2017, as well as having an experience that benefits the community partner while deepening the learning experience for students, this course better fits the Community Engagement Center's definition of Service Learning vs. Academic Internships.

(2) We also propose to reduce the number of service learning hours from 90 to 60. In conversations with CEC, 60 hours was determined to be within the range of hours for similar service learning courses. This change will reduce barriers to enrollment. It is also more consistent with the total of 135 unit hours for the course as structured currently (60 service learning hours + 75 course requirement hours = 135 total unit hours).

(3) The current prerequisite of Senior Standing presents a barrier for students who wish to take the class earlier, and students who get involved during their Junior year may have the opportunity to grow within their organizations and continue their fieldwork in PSYC 195F: Fieldwork in Community Psychology. The corequisite of PSYC 142: Community Psychology also presents an issue for students who cannot fit both of these courses into their schedules. Although it is preferred that students take PSYC 142 along with PSYC 143, PSYC 143 is designed to be a stand-alone course. We are also clarifying that students in the Peace Corps Prep certificate program are eligible for the course.

(4) We are also clarifying how students are enrolled in the course in the Course Note and Prerequisites sections. Specifically, we added: seniors will have first priority, and an application must be submitted and approved prior for instructor permission to enroll. These are procedures we currently follow and would like to state explicitly.

Course Description: (Not to exceed 80 words and language should conform to catalog copy.)

Classroom and on-site experience in community psychology. Students will complete 60 hours of service learning experience related to their community organization with supervision by authorized persons at the organization. Students will also attend class meetings to discuss the application of concepts in community psychology to their service learning experience. Topics include: ethics, structure and capacity of community organizations, working with diverse populations, and professional relationships.
