Justification for course proposal:

EDC 274 is being changed to include the 2019 CTC standards and to reflect the current field of school counseling. The field of school counseling no longer uses the word "guidance" to describe their professional work because it does not comprehensively capture the work of school counselors. Furthermore, school counselors are expected to demonstrate advocacy and leadership skills to address educational inequities. The proposed changes are to the name of the course, course description, standards and objectives, and assignments.

This course provides an overview of consultation, leadership, and advocacy models with emphasis on its use and application in school settings. The effective school counselor must be able to employ consultation, advocacy, and leadership skills in order to meet the needs of students.
