For this course, we are reducing the units from 3 to 2 to accommodate the addition of a course per the EDD approved plan. In addition, the EDD program changed the qualifying exam to a new format requiring less in-class preparation time. Therefore, the students will not have adverse impacts from the unit reduction.
