The EDD program faculty reviewed and audited its curriculum and has approved multiple related curriculum changes to update and improve its course of study. The current curriculum does not sufficiently cover basic theoretical building blocks, the historical grounding/context of contemporary policy issues, and enduring themes in educational equity. This course will address these key topics.

This course introduces major sociological theories, key education history and policy, current and reoccurring equity debates in education—concepts fundamental to educational leadership, policy, and doctoral research. It includes a survey of seminal theorists, social theory, and its application; key historical events, facts, policies, and decisions that influence and situate contemporary educational practice; and important equity debates, such as segregation and tracking, access and quality, public and private roles, testing and accountability, and others.

5. Analyze, evaluate, and synthesize social theories, education history and policy, and key ongoing and current educational debates using an equity lens;
6. Demonstrate orally and in writing an understanding of the theories, key policy, and complexities that undergird the modern education system and form the context of their decision making as education leaders;
7. Synthesize knowledge in analyzing a key current education issue or debate by writing a research paper utilizing at least two social theories and situating the debate historically and in terms of contemporary policy;
8. Apply Bloom's digital taxonomy process to their own learning – remember, understand, apply, analyze, evaluate, create.
