#### Justification for course proposal:

The California Commission on Teacher Credentialing, the governing and accrediting body for all school personnel programs in California, has substantially changed the program standards that all Education Specialist (special ed) credential programs must meet. Substantial course changes are therefore required in order to meet these new standards and new Teaching Performance Expectations (TPEs). The new programs must go into effect beginning Fall 2022 (no student can be admitted into an old program after spring 2022).

The course title has been changed to reflect the new name of this credential (old name: Mild/Moderate Disabilities Special Education, new name: Mild to Moderate Support Needs).

The course units have increased from 6 to 7 to comply with the credit hour policy (calculations were done across all credential programs to insure they are consistent and that resulted in increasing this course units from 6 to 7 in order to be consistent).

Learning outcomes have been aligned to the new standards and TPEs, as have course activities and assessments.

The course classification code has been changed from S2/CS#36 to S3/CS#25. This increases the WTUs generated from 0.33 per teacher candidate to 0.5. This is required by the CTC because all field experience/student teaching courses now require at least 6 formal observations per semester. With an S2/CS#36 (0.33 WTU) course classification code, supervisors only conduct 4 formal observations. The S3/CS#25 code is the correct code for 6 formal observations.

Course description was updated to conform to catalog copy, and to remove the 15 week phrase since some candidates need to attend their school site during finals week in order to meet teaching performance expectations appropriate for this course.

Pre-req of admission to the program was added, as this is required and had been left off previous Forms.

Very few candidates would take this course 3 times for credit, but it is possible given the design of some state-funded residency programs. Therefore, the number of times a candidate can take the course was increased from 2 to 3.

The course is required for all Mild to Moderate Support Needs candidates who are in the dual program (which adds the Multiple Subject credential) so that program was added.

The first phase of fieldwork typically occurs in the second semester (M-Th, half day) in the credential program. This semester is designed for candidates who are prepared, educationally and emotionally, for a rigorous schedule of classes and student teaching in coming semesters.
