This course expands on the Geography department's offerings for both the Human Geography and Metro Area Planning concentrations by providing an upper division course that focuses on the social, spatial, and political forces that give rise to urban change. By looking more closely at issues related to housing, gentrification, and public space, this course builds on the fundamentals of urban geography and urban and regional planning and complements the topics covered in both of those classes. Based on student feedback from the listed experimental version of this course, it will incorporate more material on gentrification and public space and role both play in urban social change and politics.

Examination of dynamic urban social, spatial, and political forces related to housing, gentrification, and public space. Attention is given to the roles of class, race, gender, and ethnicity in shaping the spaces and processes of urban transformation in cities across the world.
