Some of the topics covered in the class include Miranda Rights and terry-frisk, consent to search, border patrol interviews, reporting domestic violence.

The focus of the topics covered in this course aims to prepare linguistically competent Criminal Justice professionals that can also relate culturally to the criminal justice needs of the growing Latino/Hispanic communities in northern California.

The subject matter of this course is of interest to Criminal Justice and other professions, including Social Work and Sociology.
