Reactivate JOUR 197B. The State Hornet is growing rapidly and has recently won several national honors. This course will allow us to create unique learning outcomes for student editors and senior reporters who have prior experience on The State Hornet.

This course was part of our curriculum for many years. We experimented with combining JOUR 197A and 197B into a single course. But that has created issues, particularly with learning outcomes. Student editors who oversee dozens of reporters, along with senior reporters working on deep enterprise stories, need different learning outcomes than students new to the State Hornet.

- 5) Provide guidance and mentorship to students taking the State Hornet for the first time.

Critiques (Weekly) (ELOs 1, 2, 3, 4) - The State Hornet faculty advisor writes a weekly critique highlighting strengths and flaws of each story published during the prior week. The critique is shared with everyone in the class. It is not graded - it is an informal, constructive way for the advisor to tell students how their stories do or do not not reflect journalism fundamentals.

Professional conduct: (ELOs 3, 4, 5) - Students are evaluated on class participation, adherence to deadlines and ability to work with and motivate junior staffers. Students are also evaluated on application of ethical journalism principles, as outlined in the Society of Professional Journalists' Code of Ethics, for their own work and the work they edit.
