Philosophy of Medicine is a new course that will satisfy core elective requirements in all 3 of the Philosophy Department's concentrations, as redefined in concurrently submitted proposals. The program change is the result of the Department's attempt to respond constructively to suggestions made in the most recent program review, to rationalize course requirements across the concentrations and to infuse the existing Logic and Philosophy of Science concentration (renamed Science, Reason and Values) with a values component which creates greater coherence with the Department's identity as the primary locus of Ethics instruction at Sacramento State.
