Philosophy of Social Science is a new course that will satisfy core elective requirements in all 3 of the Philosophy Department's concentrations, as redefined in concurrently submitted proposals. The program change is the result of the Department's attempt to respond constructively to suggestions made in the most recent program review, to rationalize course requirements across the concentrations and to infuse the existing Logic and Philosophy of Science concentration (renamed Science, Reason and Values) with a values component which creates greater coherence with the Department's identity as the primary locus of Ethics instruction at Sacramento State. (Note: The term "Core Elective" has been applied to the reformulation of all concentrations for uniformity, but the core electives in the revised Logic and Philosophy of Science program (Renamed Science, Reason and Values) are in fact required. Hence, this course is identified as required for the SRV concentration below.)

An examination of concepts and problems arising in the philosophical study of the social sciences, including issues pertaining to ontology, epistemology, methodology, values & objectivity, scientific models, and explanation. Some questions explored are: What are social phenomena and social categories? What makes social science different from natural science? How do values influence the practice of social science? What kinds of mathematical and computational models are used in social science? How does social science explain social phenomena?

Your course proposal has been approved pending the following revisions: PHIL 156: Philosophy of the Social Sciences Expected Learning Outcomes need to be distinguished from one another and simplified with one action verb to suggest a sequence of learning at an advanced undergraduate level. Bloom's Taxonomy is a useful resource in this respect. For example: Students will be able to: 1) Summarize the concepts behind the most important debates in current philosophy of science 2) Analyze the various positions . . . 3) Criticize contemporary professional articles in extended written essays. And etc. Assessment strategies need to be linked to the ELO's with appropriate numbers. For example: Bi-weekly quizzes (1, 2) Mid-term exam (2) Final exam (1, 2, 3) 2 1500-word analytic essays (3) Be sure to attach a complete syllabus for the course including all of the content requested by the College of Arts & Letters.
