Sacramento State is located in the homeland of Miwok, Nisenan, and Maidu peoples and Nations. It is of vital importance for Indians and non-Indians to be aware of the histories and cultures of our first peoples of this state. California Indian Studies provides an upper-division Area F GE class that bridges instructional content and themes necessary for a NAS minor, as well as students seeking ethnic studies perspectives emphasizing a place-based approach representing the diversity of California Indian histories, stories, voices, and experiences. This course strengthens critical thinking theory and practice among not only Ethnic Studies major/minor students but also students from various majors/minors. The class will focus on California Indian activism, advocacy, cultural continuance, and revitalization with a particular emphasis on 20th and 21st centuries.

This upper division course surveys California Indian Studies. The course is a place-based approach to anti-racist and anti-colonial movements through community centered learning and is a foundational overview of contemporary political, social, economic, and environmental representations through California Indian perspectives and epistemologies. Topics can include but are not limited to: tribal citizenship, self-determination, decolonization, sovereignty, cultural revitalization, and settler colonialism.
