The honors concentration is being revised in conjunction with revisions to all other concentrations. The changes to the honors concentration are minor. Rather than six additional upper-division units of the student's choice, we are requiring that 3 of these units be any 180 series course not taken to satisfy the student's required non-honors concentration. We are also adding GPA requirements which have been enforced since the beginning of the concentration, but which do not appear in the current catalog.

#### Objectives of the degree program:

To provide a strong foundation in philosophy for majors, stressing clear, rigorous, impartial and systematic thought.

To provide students the opportunity to write a philosophy honors thesis and complete more advanced philosophy courses.
