Justification for course proposal:

Currently the painting and drawing area has a course sequence: ART 22, Beginning Painting; ART 122A, Intermediate Painting; and ART 122B, Advanced Painting. A similar sequence exists in drawing: Art 20A, Beginning Drawing; Art 20B Intermediate Drawing; and Art 120, Advanced Drawing. While the connectivity and advancement of the students' skills—both technically and conceptually— is undergirded in the groupings, we have discovered a need for further advanced-level study in both painting and drawing. (See the attached Learning Outcome sequence for Art 120, 122B and 122C)

When seeking to develop their work further many of our students take Advanced Drawing or Advanced Painting multiple times. The proposed course will offer a sequential stepping stone for further study in painting and drawing that builds a specific curriculum goal around the topic of experimental methods. Further, with the large numbers of painting and drawing students moving through the new BFA program, the faculty sees it as essential to expand upon its offerings in order to better prepare students for professional practice as artists. The experimental studies course offers this expansion for students. The class work and the work outside of class will challenge the artist to put into practice a range of experimental modes that are generated through making and through the study of historical and contemporary artists.

Experimentation is a core component of learning. In painting and drawing the experimental components of learning are active in the early stages of study but remain in the background as students focus on building their pictorial skills to articulate form, space, and illumination. Through the process of building pictorial skills, students begin to recognize the particularities of their own vision and experience – their content. It is at this point, when their own experiential content has been recognized, and pictorial skills are in place, that students need to focus more directly on the role of experimentation in their learning process. In order to develop content they will need to discover relevant methods of experimentation and apply them. Art 122C will provide students with a forum for the discovery and application of experimental methods that serve the articulation of their content. This sequence of learning is not unique to painting and drawing, and will be recognized in any discipline where development of content is the focus.

A version of this course has been offered twice in the context of a special topics seminar in our BFA degree program. These opportunities to test student's responses to the content encourage us to offer it on a regular basis in the painting and drawing curriculum. While the course will be offered under the rubric of Painting and Drawing, experimental methods embrace a wide range of approaches that can be interdisciplinary.

Finally, the addition of this course to the curriculum will mitigate problems advanced students consistently encounter with Financial Aid. Financial Aid will not support courses that are taken more than twice even though the courses allow for that repetition in the catalog. As stated above, many of our students need to take Art 120 or Art 122B more than twice in order to develop their portfolios and to complete the major. Art 122C will provide a natural sequence for this development.

Following student's work in Art 122B Advanced Painting, or Art 120 Advanced Drawing, this course will focus on investigation of experimental methods. Students will put into practice a range of experimental methods to the purpose of discovering new approaches to their medium, and new avenues for the articulation of content. Work will focus on a medium and subject matter of the student's choice.
