Briefly describe the program proposal (new or change) and provide a justification:

In compliance with EO 1071 three concentrations (Nutrition and Food, Family Studies, Fashion Merchandising and Design) in the Family and Consumer Sciences (FACS) major were elevated to stand alone degrees. The concentration of Single Subject Matter Program in Family and Consumer Sciences (pre-credential) is all that remains. No changes are proposed to the curriculum of the pre-credential so that we can maintain our single subject waiver with the Commission on Teacher Credentialing. Some edits are proposed due to changes in course subject codes from FACS to NUFD, or FSHD, or FASH. This single subject program is the only one in the CSU with a single subject waiver and one of just two public institutions in California with pre-credentials in Family and Consumer Sciences. While the state grapples with a shortage of credentialed teachers, we feel that it is critical to keep this program to prepare future Career and Technical Education teachers for middle and high schools.

We are also seeking to change the degree designation from Credential to Bachelor of Science.

Objectives of the degree program:

The BS in Family and Consumer Sciences provides breadth among the disciplines of Family and Consumer Sciences, drawing from Nutrition and Food, Fashion Merchandising and Management and Family Studies and Human Development, and academic pre-credential skills necessary for teaching FACS at the secondary level. Successful completion of the BS in FACS also satisfies the demonstration of subject matter competence required by the CA Commission on Teacher Credentialing. Students who complete the program are exempt from the CSET exam in Family and Consumer Sciences.

Graduates are prepared to enter the Single Subject Teaching Credential Program required to teach Family and Consumer Sciences/Home Economics in middle and high schools. Completion of the degree meets the single subject content requirement for a subsequent teaching credential with a waiver of the CSET (California Subject Examinations for Teachers). For students who want to earn their teaching credential from Sacramento State, it is possible to finish the prerequisite courses while completing this degree to avoid additional out of pocket tuition and fees.
